BASIC PROGRAM INFORMATION

- ELIGIBLE ACRES ARE THOSE NOT PREVIOUSLY PLANTED TO COVER CROPS
- COVER CROP MUST BE PLANTED BETWEEN APRIL 1, 2024 AND NOVEMBER 8, 2024
- 7,000 ACRES AVAILABLE THIS YEAR
- 40 ACRE MINIMUM, 1,500 ACRE MAXIMUM
- \$20 PER ACRE REIMBURSEMENT FOR SEED COST ON QUALIFIED ACRES
- PARTICIPANTS AGREE TO PROVIDE FSA-578 DOCUMENTATION FOR ENROLLED ACRES AND RE-CEIPT FOR PURCHASE OF COVERCROP
- PARTICIPANTS AGREE TO PROVIDE FIELD CROPPING AND PRACTICE HISTORY FOR FIELD-TO-MARKET FIELDPRINT CALCULATOR
- PARTICIPANTS AGREE TO WORK WITH AARON SAWYERS TO GET THE INFORMATION FOR THE FIELDPRINT CALCULATOR
